One carrier annually would pledge to match the funds collected up to a certain level. We printed tickets and raffled items to collect money. Kudos to the marketing folks of our company partners as they went out and sold those tickets.

With the money collected we bought toys and set to distribute them. We contacted the Jackson Memorial Hospital Children Wing (Now Holtz Childrens Hospital) and asked how many toys they needed depending on the age and gender of the kids.

To top it all, Fernado decided to dress as Santa Claus and recruited Elves (Board members and family) to help distribute them. This tradition continues with the Miami-Dade Chapter and event though Fernado is no longer with us the tradition of dressing as Santa and delivering toys to the renamed Holtz Children Hospital continues with his son David Gimenez who has kept the tradition alive for the last seventeen years.

Progressive Drops Some Agents, Non-Renews 100,000 HO and DP Policies in Florida

Almost two years after Progressive Insurance announced it would stop renewing some homeowners policies in Florida, Flo and crew have dropped another 100.000 HO and landlord policies in the state.

The insurance giant and Florida regulators said Progressive had struck an agreement with Tampa-based Loggerhead Reciprocal Insurance Exchange, a recent entrant into the Florida market, to offer replacement policies for affected customers early next year.

The dropped HO policies were considered "high risk," although Progressive did not say which counties were most impacted. The carrier also will discontinue dwelling-fire and DP-3 policies in the state, and will begin sending nonrenewal notices in late December.

Also, the company said it has determined that certain agents will no longer represent Progressive Home insurance. The insurer did not name the agents but said they would be notified soon.

In a statement, Progressive said it needed to take the actions "to ensure we can be a long-term. viable property carrier option" for independent agents.

"While we need to make these business decisions to help rebalance our book, we're encouraged by and grateful for the work of Florida state officials who helped recently enact needed legislative reforms...

OIR Approves an 15.1% Decrease in OIR Approves an 15.1% Decrease in Workers' Compensation Insurance Rates for 2024

Florida Insurance Commissioner Michael Yaworsky issued a Final Order granting approval to the National Council on Compensation Insurance (NCCI) for a statewide overall workers' compensation insurance rate decrease of 15.1 percent. The rate decrease applies to both new and renewal workers' compensation insurance policies effective in Florida as of January 1, 2024.

"As a former small business owner myself, I'm always working to support Florida's small businesses and entrepreneurs. A decrease in workers' compensation rates means lower insurance costs for employers, allowing them to put more money back into their business, where it belongs," said Chief Financial Officer Jimmy Patronis. "I'm pleased that Florida's business owners will benefit from another year of rate relief and look forward to keeping Florida the best place to live, work, and run a business."

"Today's announcement means more cost saving opportunities for every business operating in Florida," said Agriculture Commissioner Wilton Simpson. "Florida is committed to supporting small businesses and I look forward to seeing another year of reduced workers' compensation rates."

"I'm pleased to announce that Florida businesses will see a reduction in workers' compensation rates for the seventh consecutive year," said Insurance Commissioner Michael Yaworsky.

2024 Personal Lines Rate Cap Change

For Personal Lines policies that are subject to Citizens' glide path, the Florida Office of Insurance Regulation (OIR) has approved changes that may result in an increase to the statutory maximum allowable individual rate change cap ("glide path").

Per Florida law, Citizens' annual base rates cannot increase by more than 13% for new and renewal policies effective on or after February 1, 2024, excluding:

- * Coverage changes
- * Mitigation adjustments
- * Sinkhole loss coverage
- * Surcharges and assessments
- * A required rapid cash-build-up provision for the Florida Hurricane Catastrophe Fund (FHCF) if applicable.

This capping factor change is separate from the rate increase announced on November 6.

Notes:

- * As a result of Senate Bill 76, Citizens began increasing the capped glide path on rate increases by 1% annually until the cap reaches 15% in 2026.
- * The rate cap applies to policies insuring a primary residence. Policies that insure a non-primary residence will receive a higher capping factor.

2024 Commercial Lines Rate Cap Change

The Florida Office of Insurance Regulation (OIR) has approved changes for all Commercial Lines policies that may result in an increase to the statutory maximum allowable individual rate change cap ("glide path").

Per Florida law, Citizens' annual base rates cannot increase by more than 13% for new and renewal policies effective on or after March 1, 2024, excluding:

- * Coverage changes
- * Mitigation adjustments
- * A-rated risks
- * Required surcharges and assessments
- * A required rapid cash-build-up provision for the Florida Hurricane Catastrophe Fund (FHCF) if applicable.

The Rates and Rating manuals have been updated as needed.

Notes:

This capping factor change is separate from the rate increase announced on October 9.

As a result of Senate Bill 76, Citizens began increasing the capped glide path on rate increases by 1% annually until the cap reaches 15% in 2026.
