### Aon to Buy Middle-Market Broker NFP for \$13.4 Billion

Aon plc this morning said it has a \$13.4 billion deal in place to purchase broker NFP to expand its middle-market segment.

The purchase price will be funded by \$7 billion in cash and \$6.4 billion of Aon stock. Closing is expected mid-2024, Aon said.

"We have continually evolved our leading capabilities to better serve our clients' growing needs amidst increasing volatility across the marketplace," said Greg Case, CEO of Aon, in a statement. "The acquisition will advance our relevance to clients, create opportunities for our colleagues and further strengthen our shared cultural values."

NFP chief executive Doug Hammond will continue to lead NFP, a leader in P/C brokerage, benefits consulting, wealth management and retirement plan advisor for middle-market clients, as an independent but...

connected platform within Aon under the brand "NFP, an Aon company." Hammond will report to Eric Andersen, president of Aon.

"Doug and NFP have built an exceptional team, with a complementary one-firm mindset, and we expect to both learn from their entrepreneurial culture and share with them the depth and breadth of our capabilities to create more value for clients, colleagues and shareholders," Case added.

Aon-NFP Merger a Win-Win for Middle Market Segment, Aon Says

NFP has used M&A to grow, with more than 200 completed transactions since 2018. According to its website, New York-based NFP in 2022 had P/C revenue of \$738 million as well as \$1.1 billion in revenue from benefits and life, and \$362 million in revenue from its wealth and retirement business.

## Florida Bill Would Require Option of Policies That Cover Only Unpaid Mortgage Amount

Ahead of Florida's 2024 legislative session that begins Jan. 9, at least a dozen bills have been filed that could have an impact on the state's insureds and insurers. It's a sign that lawmakers are under renewed pressure to take further steps to reduce still-rising property insurance rates.

Most of the bills have been introduced by Democrats, and they have been given little chance of passage in the Republican-controlled Legislature this year. But one measure, offered by Republican Rep. Alina Garcia, of Miami, has generated some buzz as a back-door approach to reducing exposure for insurers and cutting premiums for homeowners.

House Bill 809 and its companion, Senate Bill 1070, would require insurance companies to offer HO policies that cover only the unpaid principal on a mortgage. Such a move would satisfy mortgage company requirements that protect the loan but could conceivably trim premiums that are usually based on full coverage and the replacement value of a home.

"I don't really see a downside to it for insurers," said Chris Burand, a Colorado-based industry consultant who keeps an eye on the Florida market.

## Depopulation: New Process for Risks **Returning to Citizens**

Citizens is implementing a new document exception process that applies to new-business policies effective December 6, 2023, & assumed June 2023 & later.

This new process applies to such customers reapplying to Citizens after an assumption due to the takeout company's offer being higher than the estimated premium presented at time of assumption, making it more than 20% higher than Citizens' current rates.

#### Eligibility Requirements

Eligibility requirements have not changed. The Declarations page issued by the takeout company should be used to support marketing to other carriers and to determine the 20% eligibility rule with Citizens.

- \* Agents should use a comparative rater or a quote from the portal(s) of their appointed carrier(s) to determine if the customer has an opportunity to be placed with another company in the private market.
- \* Agents must complete a quick quote in PolicyCenter® to compare with the takeout company and private-market offers.
- \* If an agent determines the risk is eligible for Citizens' coverage under the 20% rule, the risk may be submitted to Citizens as new business.
- \* A final determination of the 20% rule will be based on the takeout company \*
- \* Declarations page premium and Citizens' new-business application premium.
- \* Pre-Qualification Question should be answered as Option B.
- \* The risk must meet all of Citizens' underwriting requirements, including required flood insurance when applicable.
- \* The effective date of the new Citizens policy cannot be before the current policy's expiration.
