Our chapter had the honor of hosting the honorable John King, the Insurance Commissioner of Georgia. He spoke at our luncheon event on February 21st at Maggiano's. Mr. King informed our members and attendees that Georgia is suffering from commercial auto carriers leaving the state of Georgia. Small business owners cannot afford the high premiums due to a lack of markets and loss trends. Mr. King advised the audience that he is supporting to amend and remove in the direct action. Georgia is one of the few states that have this law, and it has adversely affected carriers who remain in the state of Georgia. Due to the lack of legal reform and the increase of repair and claims, the consumers are the unfortunate victims because they are the ones who pay the higher cost due to the adverse claims in Georgia. Mr. King informed the audience that Georgia is pulling out of the Affordable Care Act program and will have its subsidized plan in the marketplace. The intent is to bring premium relief to small businesses. Agents and brokers must qualify through a certification program to sell this exclusive insurance product.

Georgia Senate Approves End to Direct-Action Suits vs. Truck Insurers

ATLANTA (AP) — Georgia senators are moving to limit the ability of people to sue insurance companies directly in lawsuits over trucking accidents.

The Senate voted 46-2 on Tuesday to pass Senate Bill 426, sending it the House for more debate.

The measure says someone could only sue the deep pockets of an insurance company directly when the trucking company involved in the lawsuit has gone bankrupt or when the plaintiff can't find the truck driver or the trucking company to serve with a copy of the lawsuit.

Supporters say the change would result in lower insurance rates for truckers, arguing current rates inhibit trucking companies' ability to do business.

Tillery

Sen. Blake Tillery, a Vidalia Republican sponsoring the measure, characterized it as a compromise between business groups and lawyers, saying it would "advance the ball and stabilize rates." Tillery said there are elements that he might personally not favor as a lawyer who represents plaintiffs.

Proof of Primary Residency Updates

As previously announced on October 3, 2023, in the Personal Lines Bulletin: Proof of Primary Residency and Webinars, to avoid a higher capping factor at renewal for policies effective December 16, 2023, and later, agents should contact policyholders to determine occupancy and provide proof of primary residence prior to the policy renewal date.

As a reminder, under Florida law, a primary residence is defined as: (a) the policyholder's primary home, which the policyholder occupies for more than nine months of each year; or (b) a rental property that is the primary home of a tenant, which that tenant occupies for more than nine months of each year.

Homestead Exemption Status

An enhancement soon will be added to PolicyCenter® to determine the homestead exempt status on new-business submissions that are effective December 16, 2023, or later so that primary/non-primary determination can be made. The enhancement determines the primary residence status based on policy type and homestead information provided without the need to submit supporting documentation. If the system determines the residency is non-primary, the agent can decline the results and submit acceptable documentation as proof of primary residence (see below).

Note: This does not apply to renewals unless there is a policy change submitted requesting an update from non-primary residence to primary residence.

Utility Bills Are No Longer Acceptable

Utility bills are no longer acceptable proof of primary residency because if the policyholder lives out of state, the utility bill still indicates the property address.
